

Notice and Demand Reply

Please note that pursuant to Rule 573, the accused requires immediate notice of all experts that may be called in the prosecution's case-in-chief. You are also put on notice that a laboratory report will not suffice. We object to the introduction of any evidence without proper foundation, personal knowledge and the like. Pursuant to Rule 574, we demand the presence of all of the witnesses that were involved in the collection, transportation, custody, care, manipulation, altering, analysing, testing, quality control, quality assurance, and interpretation of any of the evidence used in this case. Demand is hereby given pursuant to Pennsylvania Rule of Criminal Procedure Rule 574 that

the actual person performing the analysis must be present in court. We will not stipulate to the admissibility, relevance or authenticity of any report, testimony or other information. Also pursuant Rule 573, if the prosecution intends to call any witness to the stand to be anything other than a straight fact witness, we require this witness's detailed report. This report must be a classically prepared one that is traditionally seen in civil cases. It must include the nature of the opinions rendered, the source of the opinion and the facts relied upon to make that determination. Additionally, even if the expert is simply going to be used to explain a concept to the trier of fact, then the defence requires that expert to render an expert report in that regard. A *curriculum vitae* for these witnesses is also requested.


